Purpose of Mr. Piercey's attendance was to discuss the proposed five (5) day schedule for the upcoming Arena Schedule.

Mr. Piercey informed Council he was unable to handle a five day schedule due to ice maintenance, equipment maintenance and cleaning the Arena Facility.

He stated that Witbourne had 58 rental schedule hours with three full time men; Harbour Breton 26-28 rental hours with one full time and one part time employee.

Mr. Piercey noted that with two days down-time there would have to be someone checking the equipment, it would take approximately 2 hours for him to clean the ice when he returned to work due to the condensation and build up of lumps on the ice.

He also noted to Council that at present he often checks on the equipment while he is on his time off and with no charge to Council. Mr. Piercey asked what Councils plans were for a back-up person, if they were needed?

Mayor Penwell thanked Mr. Piercey for attending and informed him Council would discuss the matter in detail and would notify him of their discussion. Mr. Piercey retired form the meeting at 7:45p.m.

A lengthy discussion was held regarding the Arena operation, and the items noted by Mr. Piercey were discussed in detail.

It was agreed to have Mr. Piercey's schedule arranged for Thursday through to Sunday (40 hours), Arena closed Monday & Tuesday, and a part time employee to work the regular scheduled hours for Wednesday.
